



Dear Re-applicant,

The Hampden County 4-H / Youth Special Fund renews scholarships to qualified college level Hampden County 4-H members, former members or Hampden County applicants involved in a previous or current agricultural endeavor. To re-apply for a scholarship, fill out the application form completely and comply with the requirements on **page 2**. Return the application materials to the address listed at the bottom of **page 1**.

The scholarship criteria are as follows:

- 1. Scholarships may be renewable upon re-application if a **2.2 cumulative GPA** is maintained and a minimum of **24 credit hours or equivalent** are completed each year.
- 2. Scholarships are limited to four years unless the applicant is pursuing post-graduate studies in an agricultural field.
- 3. The applicant must fully complete all the application materials required to be a scholarship candidate.
- 4. Applications and pertinent information must be post marked or received by **June 1**st. Any information received after that date will not be considered. **No exceptions.**
- 5. Recipients of the scholarship will be notified by July 1st.
- 6. No awards shall be issued if, at the discretion of the Scholarship Committee, there are no qualified applicants.
- 7. Scholarships shall be payable directly to the college.
- 8. Each scholarship will be in an amount **up to** \$1,000.00.

- 3 copies of the activities/award/experience list
- 3 copies of the statement
- Most recent official grade transcript
